The Zimbabwe Electoral Commission (ZEC) is an Election Management Body established in terms of Section 238 of the Constitution of Zimbabwe. Its main function is to prepare for, conduct and supervise all elections and referendums in Zimbabwe. The year under review saw the successful conduct of the Harmonized Elections, by-elections and the conclusion of the delimitation exercise in terms of the Constitution of Zimbabwe. In addition, all vacant proportional representation seats in the National Assembly and local authorities were filled in terms of the law. The Commission was allocated ZWL\$896 billion to support the electoral processes of which ZWL\$664 billion (74%) was accessed.

With a full complement of Commissioners, 2023 saw the Commission meeting six (6) times in line with the provisions of the law. In addition, the Commission recruited sixty-six (66) new employees, with 40% being females and 60% being males.

Whilst maximizing on fourteen (14) languages out of sixteen (16) which are enshrined in the Constitution, the Commission made use of various methods and media platforms to provide electoral related information to the masses. Voter registration played a pivotal role in as far as inclusion is concerned within the electoral process. With regards to voter registration, 2023 saw a total number of 705243 voters being registered of which 330979 were male and 374264 were female.

The Commission conducted an annual stock-take in terms of the Public Finance Management Act [Chapter 22:19]. In accordance with section 92(2) of Public Procurement and Disposal Assets Act [Chapter 22:23]. the Commission also disposed obsolete assets and equipment which included vehicles and furniture among other things and realized a total amount of USD168000. The Commission also conducted renovations at its head office, provincial, district offices as well as warehouses.

Finally, during the year under review, the Commission participated at various international events. These events are important for knowledge sharing and benchmarking of electoral standards .



The Zimbabwe Electoral Commission is pleased to submit its annual report for the year 2023 in terms of section 323 of the Constitution of Zimbabwe as read with section 13(2) of the Electoral Act [Chapter 2:13]. This report covers the conclusion of the delimitation exercise as well as the conduct of the 2023 Harmonised Elections. The report also gives a summary of by-elections conducted across the country and other activities by the Commission.

The Commission was able to fulfil all its statutory functions and met six (6) times in line with its corporate governance expectations outlined in the relevant law. This was despite the various challenges and demands from its other constitutional mandates during the year under review.

With regards to international engagement, the Zimbabwe Electoral Commission participated at different fora which included election observation in the Democratic Republic of Congo (DRC), ECF SADC 25th Annual General Conference held in South Africa as well as various other meetings related to that body. The Commission also participated in staff development courses on election management and conflict resolution in Russia, Japan and South Africa.

The Commission expresses its profound gratitude to the Government of Zimbabwe and other stakeholders for all the support rendered during the year under review. Last but not least, the Commission expresses its gratitude to the entire staff for the commitment and dedication to duty during this difficult period

Overall Functions of the Commission (Section 239 of the Constitution)

- a. To prepare for, conduct and supervise-
- i) Elections to the office of the President and to Parliament;
- Elections to provincial and metropolitan councils and the governing bodies of local authorities:
- iii) Elections of members of the National Council of Chiefs; and
- iv) Referendums, and to ensure that those elections and referendums are conducted efficiently, freely, fairly, transparently and in accordance with law,
- To supervise elections of the President of Senate and the Speaker and to ensure that those elections are conducted efficiently and in accordance with the law;
- To register voters;
- d To compile voter's roll and registers;
- e To ensure the proper custody and maintenance of voter's roll and registers;
- To delimit constituencies, wards and other electoral boundaries;
- To design, print and distribute ballot papers, approve the form of and procure ballot boxes, and establish and operate polling centres;
- To conduct and supervise voter education;
- To accredit observers of elections and referendums;
- To give instructions to persons in the employment of the State or of a local authority for the purposes of ensuring the efficient, free, fair, proper and transparent conduct of any election or referendum; and
- To receive and consider complaints from the public and to take such action in regard to the complaints as it considers appropriate.

Additional functions of the Commission (Section 5 of the Electoral Act [Chapter 2:13])

In addition to the functions set out in section 239 of the Constitution, the commission is responsible for:

- Undertaking and promoting research into electoral matters: and
- Developing expertise and the use of technology in regard to electoral processes; and
- Promoting co-operation between the Government, political parties and civilsociety in regard to elections; and
- Keeping the public informed about the times and places where persons can register as voters and the progress of the voter registration exercise, and
- The delimitation of wards, constituencies and other electoral boundaries; and
- The location and boundaries of polling stations and when they are open; and
- Voters' roll and the times and places at which they are open for inspection; and
- Political parties and candidates contesting every election; and Voting; and
- Generally, all matters relating to the Commission's work and the electoral process; and
- Ensuring that gender is mainstreamed into electoral processes; and
- Making recommendations to Parliament on appropriate ways to provide public financing for political parties.

Governance of the Commission

The Zimbabwe Electoral Commission (ZEC) is established in terms of Section 238 of the Constitution of Zimbabwe. It consists of a Chairperson, who, by operation of the law, should be a Judge or former Judge or a person qualified to be appointed as such, appointed by the President after consultation with the Judicial Service Commission and the Committee on Standing Rules and Orders, and eight (8) other members, appointed by the President from a list of nominees submitted by the Committee on Standing Rules and Orders. 
CHIEF ELECTIONS
OFFICER

Staff of the Commission

The Commission is serviced by a full time Secretariat headed by the Chief Elections Officer. It is empowered by the Electoral Act (Chapter 2:13) to employ other staff in addition to the Chief Elections Officer. The Secretariat comprises full time employees in the following Divisions:

- i) Operations
- ii) Administration; and
- iii) Knowledge Management and Communication

These Divisions are replicated, albeit at smaller scale, at Provincial and District levels. Under these divisions are various Departments, each dealing with specific issues such as Elections and Training, Voter Education, Voter Registration and Delimitation, Election Logistics, Administration, Human Resources, Information Communication Technology, Finance, and Research and Development, Public Relations. The Commission also has Legal, Procurement, Internal Audit and Security which offer support to the institutions. The Commission is decentralized into 10 Provinces and 68 Districts



Programmes of the Commission

The Commission has two (2) Programmes in line with Programme based Budgeting (PBB).

FINANCE

Budget Performance

In 2023 the Commission successfully conducted the voter registration and inspection exercises, delimitation of electoral boundaries and the actual conduct of the harmonised general elections. These deliverables were in line with its constitutional mandate and strategic priorities and conformed to the National Development Strategy (NDS) 1. Further, in line with sections 322 and 325 of the Constitution which provide for Parliament and government to ensure that adequate funds are appropriated to enable effective performance of the Commission's functions, a total of ZWL\$896 billion was allocated to support the electoral processes of which ZWL\$664 billion (74%) was accessed. However, this forced the Commission to carry forward to the next financial year outstanding payments on election allowances and suppliers of goods and services among other things. At the time of compilation of this report treasury was seized with the matter to clear outstanding payments.

Challenges

The Commission faced some of the following challenges related to the performance of its mandate during the year under review

- the instability of the exchange rate which weakened the purchasing power of the allocated financial resources.
- the need for advance payments by suppliers of goods and services affected timeous procurement of goods and services thus derailing timely support for the election activities. Some service providers declined to provide their service where there was no advance payment which in some cases, resulted in delayed deployment of election material.
- delays in funding of election activities resulting in accrued expenditure.

It is recommended that in future payments to service providers be prioritised to avoid disruption of service during critical electoral activities. Further, there is need for timeous availing of financial resources during election activities to avoid prejudicing stakeholders.

Corporate Governance Issues

Meetings of the Commission

- The law provides that the Commission must meet a minimum six (6) times during any given year.
- During the year under review, the Commission met six (6) times in line with the said legal requirements

HUMAN RESOURCES MANAGEMENT

ZEC Secretariat Staff Establishment

ZEC has an establishment of six hundred and eighty (680) posts. Of these, five hundred and fifty four (554) posts are filled. In addition, there are fifty-eight (58) ZRP Special Constabularies seconded to ZEC for security duties.

Thirty two percent(32%) of ZEC top management (i.e. Grade 1 to Grade 3a) are women and overall 45% of ZEC employees are women.

Appointments

The Commission recruited sixty-six (66) new employees during the year under review. Of those recruited 40% are females and 60% are males. All posts were advertised internally first and then externally where suitable and qualified internal candidates were not identified. However, nine offers were rejected due to unattractive salary packages

In addition during the year under review, the Commission recruited about one hundred and fifty thousand (150, 000) seconded staff from eligible institutions in line with provisions of Section 10 of the Electoral Act [Chapter 2:13] for purposes supporting the management of electoral activities.

Terminations

A total of thirty-nine (39) employees terminated employment with the Commission as tabulated below. Therefore, the staff attrition rate was 7% as at 31 December 2023.

The number of retirees is high as it depicts statistics for two years (i.e. 2022 & 2023). The Commission deferred some retirements to December 2023 in order to utilize the services of the affected experienced employees for the 2023 Harmonized elections.

INFORMATION AND COMMUNICATION TECHNOLOGY

The Commission increased the internet bandwidth to a total of 100mbps and hosted services (PFMS, and RBZ PORTAL) a dedicated 10mbps, slightly improving the network performance. The VPN connectivity to District offices was increased from 1mbps to 10 mbps. Voice over internet protocol VoIP was implemented at Head office call Centre and successfully tested across all Commission offices and now pending a National roll out.

The Unstructured Supplementary Service Data (USSD) code *265# is currently available to the NetOne and Econet Subscribers and available to Telecel subscribers with 2G and below handsets for inspection of voter registration details. Efforts are still underway to accommodate all Telecel Subscribers.

LEGAL

In the year under review, the Electoral Act was amended to align with Constitutional provisions on the youth quota and local authority youth quota which were introduced through the Constitutional Amendment No: 2 Act of 2021. However the amendments could not be used in August 2023 Harmonized Elections. Below is a summary of the amendments. The Commission will propose additional amendments after conducting post-election reviews for the 2023 Harmonized election.

Introduction of definition: "Disqualifying Offence"

The Act introduces a definition of "disqualifying offence". Currently under section 129(1)(i) of the Constitution one would be disqualified from continuing as a member of Parliament if he or she is convicted of an offence of which breach of trust, dishonesty or physical violence is an essential element. The Act thus seeks to ensure that any such person who would be disqualified from continuing as an Member of Parliament (MP) for committing such an offence should not also be allowed to stand as a candidate for election. The provision would also apply to persons seeking election in local authorities because the provisions that disqualify one from being an MP also disqualify a person from being a councillor. Thus, for one to be accepted as a candidate he or she will be required to make a solemn declaration in a nomination form or by means of an attached affidavit, that he or she is not a convicted of a disqualifying offence (or has received a pardon for such offence).

Making a false declaration in a nomination paper or affidavit that one has not been convicted of a disqualifying offence or that one was pardoned of such an offence shall constitute a criminal offence.

Note: for one to be disqualified one must have committed the offence within the period of 12 months before date of nomination and sentenced to imprisonment for a period of six months or more without the option of a fine or without the option of any other non-custodial sentence.

Amendment of Section 21 of the Act on inspection of the Voters roll.

Subsection (2) of section 21 of the Electoral Act was amended to allow a person inspecting the voters roll to, without removing the voters roll, take a photograph or make a copy of the roll or any part of it. Previously one was only permitted to make written notes of anything contained in it.

Further, subsections (3), (4) and (6) of section 21 were amended by the deletion of "within a reasonable time" and the substitution of "within five working days" thus compelling the Commission to make the voters roll available within five working days from the day a person requests it, or after the election is called for or after the nomination day as the case may be.

Amendment of section 45B

The amendment replaces the definition of "party-list seat" so as to include the youth and local council women's seats in conformity with the Constitutional Amendment No. 2 which introduced the youth quota in the National Assembly and the 30% women's quota in local councils.

Amendment of section 45C

This amendment replaces 45C(4) of the Electoral Act so as to include the allocation of 1 youth seat to every electoral province.

The clause also introduces subsections (7) and (8) which states that for every local authority there shall be elected by indirect proportional representation a 30% Women Quota calculated as follows:

30 x Number of wards in local authority concerned

100

Note: any fraction of less than half being rounded downwards to the nearest integer and any fraction of a half or more being rounded upwards to the nearest integer

Note further: The formula prescribed in the Eighth Schedule for the election of party-list candidates is calculated on the basis of the total number of valid votes cast for all the candidates in the local authority concerned, **excluding any valid votes cast for such candidates**.

- (a) not belonging to any political party; and
- (b) belonging to any political party which has opted not to field any party-list candidates for the local authority concerned.

Amendment of section 45D

This amendment clarifies the position that if one is nominated for election in any other election then their nomination on the youth party list or the women's local authority party-list is void i.e. where a candidate is nominated more than once all the nominations of the person as a party-list candidate shall be void.

Amendment of section 45E

Section 45E is amended in subsection (1)(b) by requiring political parties to submit 5 party lists to the nomination officer. The party lists shall be for:

- a. The Senate;
- b. National Assembly Women's Quota;
- c. National Assembly Youth's Quota; and
- d. Provincial Council.

30% Women's quota for the local authority concerned

Amendment of section 46 on Nomination of Candidates

The nomination form must now contain space for a declaration or, if no such space is available, shall be accompanied by an affidavit to the effect that the would-be candidate has not been convicted of a disqualifying offence (or, if so convicted, has been pardoned by the President or by virtue of an Act of Parliament). A candidate shall not be regarded as duly nominated for election if he or she has been convicted of a disqualifying offence without being pardoned therefore (see new insertion in 46(15)(d1)

Further, any person who as a candidate, makes a false declaration in a nomination paper or in an affidavit accompanying such nomination paper that he or she is has not been convicted of a disqualifying offence or has received a pardon therefore shall be guilty of an offence and liable to a fine or to imprisonment or to both such fine and imprisonment.

Amendment of section 47 on nomination fees

The section was amended by the insertion of subsection (2) which provides that the "nomination fee shall neither be exorbitant nor inhibitive but reasonable enough to allow an eligible citizen to stand for election for public office".

Amendment of section 119 on qualifications and disqualifications for election as a councillor

The section was amended so as to include that a person is disqualified from being nominated as councillor if he or she has been convicted of a disqualifying offence for which he or she has not received a pardon.

Withdrawal of Candidate

In order to afford sufficient time for ZEC to make changes to the design of the ballot and to advise the electorate of any changes to the candidature of that election, sections 49 and 126 of the Electoral Act were amended so that they are aligned to section 107(1) of the principal Act which provides that withdrawals by candidates must be made at any time before twenty one days from polling day.

Amendment of section 169 on Service of a petition on a respondent

The section was amended and replaced by a new section which provides that apart from service of an election petition on a respondent (respondent being the President, or a Member of Parliament or a Councilor whose election or qualification for holding office is complained of) if an election petition complains of an act or omission on the part of the Commission or any employee or agent of the Commission or any public officer, the petitioner shall cause the petition and other documents to be served also on—

- (a) the Commission; and
- (b) the employee, agent or public officer.

Where an election petition and other documents have been served on a person referred to in subsection (2), that person shall have the same rights and responsibilities in regard to the petition as the respondent.

Amendment of Eighth Schedule

The amendment provides an example of how the 30% women's quota in local authorities shall be calculated.

DELIMITATION

The Zimbabwe Electoral Commission concluded the delimitation exercise in terms of the provisions of the 2013 Constitution of Zimbabwe. This was the first delimitation exercise to be conducted using the 2013 Constitution. The last delimitation exercise was done in 2008. The Delimitation Report was gazetted by the President of the Republic of Zimbabwe on the 20th of February 2023. The delimitation exercise created 210 constituencies as prescribed in the Constitution and 1970 wards.







STAKEHOLDER ENGAGEMENT AND PUBLICITY PROGRAMMES

In the year 2023, the Commission employed various media platforms and initiatives to provide electoral related information to the public in the following languages: Chewa, Chibarwe(Sena), English, Kalanga, Nambya, Ndau, Ndebele, Shangani, Shona, Sotho, Tonga, Tswana, Venda and Xhosa.

Radio and TV Programmes

ZEC produced **70** TV and radio advertisements that were running on Classic 263, Breeze FM, YaFM, Diamond FM, Hevoi FM, Platinum FM, Radio Zimbabwe, the national TV as well as the following community radio stations:



Billboards

The Commission erected 40 billboards across the country, 4 in each province targeting motorists and locals. These conveyed messages on peaceful elections and inclusive participation in electoral activities.

Flipcharts

The Commission utilised A1 and A3 flipcharts for the 2023 Harmonised Elections. The flipcharts carried comprehensive information on the various electoral processes in the 2023 Harmonised elections

Road shows

ZEC conducted **20** road shows across the country with the support of UNDP.

Exhibitions

The Commission exhibited at the Zimbabwe International Trade Fair under the theme "Continuous Innovation for Credible Elections". However, the Commission could not exhibit at Zimbabwe Agricultural Show because they coincided with preparations for the 2023 Harmonized Elections.

ZEC Website

The full migration from the old website to a new website compatible with mobile phones was completed. The website is now fully functional and more than 100000 users visited it during the year under review.

ZEC Social Media Accounts

ZEC Facebook and X accounts were regularly updated and all followers were fully engaged. By year end, the number of X followers had risen to **263**, **400** from **197**, **400** recorded in 2022.

Multiparty Liaison Committees

The Commission launched the National Multiparty Liaison Committee on 04 April 2023 in preparation for the 23-24 August 2023 Harmonized Elections. Multiparty liaison committee meetings were held at national, provincial, district and constituency levels.

Radio jingles

The Commission utilised jingles and skits to convey electoral messages to the electorate.

Call Centre

ZEC established a call centre to receive and transmit information to the electorate on various electoral processes using Econet, Netone and Telecel platforms.

Promotional materials

The Commission produced and distributed to the public promotional materials such as T-shirts, hats, bandanas, rulers, pens, branded note books, desk and wall calendars.

Accreditation of Observers and Journalists

The Commission accredited a total of **12**, **512** both local and foreign observers and journalists for elections in the year under review in terms of Section 40 I of the Electoral Act [Chapter 2:13].

Observer Briefs

The Commission held the first national elections observer briefing on 08 July 2023. More than **120** accredited observers and media practitioners attended the briefing. A second briefing was held on 16 August 2023 and about **1, 200** local and foreign observers attended.

Private Voluntary Organisations (PVOs)

The Commission authorised **46** PVOs and FBOs to assist in providing voter education.

PROGRAMME 2 ACTIVITIES

VOTER REGISTRATION

Whilst voter registration is an ongoing exercise at every district and provincial offices, the Commission conducted two (2) national outreach mobile voter registration exercises in preparation of the 2023 Harmonised Elections. A total of 705, 243 voters registered in 2023 as shown in Table 3 and 4 below. The total number of registered voters by Province and age group as at 31 December 2023 is presented in Table 5 and figure 1

Figure 1: Voter Population by age group:


